## Project Registration Program

Register your project, and receive an *extra 5% discount!*

ClearOne knows that many of our authorized value-added resellers specify end-customer projects that may go out for bid. You are being rewarded for your early identification of projects and commitment to specify our products in these projects.

By submitting the Project Registration Request Form and any supporting documents detailing your project specification, you are stating that your firm has identified the customer project and created the system design for which you wish to receive special bid pricing.

### The Program:

1. **Please note, the minimum order to qualify for project registration, has changed.** A minimum of \$25,000 CAD worth of ClearOne products, valued at reseller cost, is required.
  2. Authorized value-added resellers should submit their project registration forms to ClearOne at the time of project specification. Registrations will be awarded to the first authorized reseller who submits a fully completed project registration form.
  3. ClearOne will respond to all registrations, with notification of either a) acceptance of registration and award of discount, b) request for further information to determine the validity of the request, or c) refusal of the registration
  4. Submission of the project registration form shall not constitute acceptance by ClearOne and therefore the reseller, until verified by ClearOne corporate management, shall not assume the granting of special registration pricing.
  5. To be confirmed as the specifying registered reseller, ClearOne must be able to verify that the project is a direct result of the submitting reseller's effort to create the original specification/proposal for our products. ClearOne projects that are originated and specified by design consultants or independent design/build firms are not eligible for project registration by resellers.
  6. Upon ClearOne's approval and award of the selected value-added project registration form, reseller will receive a 5% discount for the project from their respective pricelist.

## Terms and Conditions:

- + This program is only applicable for authorized Canadian direct and indirect resellers who have been certified for relevant Pro Audio and AV products. Please see your ClearOne Rep for questions.
- + Approved project registrations are valid for 6 months from the registration date. ClearOne maintains the right to determine the validity of the request and a decision. Projects smaller than the minimum amount will not be considered for registration. Extensions will be granted at the discretion of ClearOne.
- + Any special pricing provided will be valid for that project only, and does not constitute special pricing granted to the Reseller for other ClearOne projects.
- + Discount amount will be calculated as an additional discount to the standard price applicable to the awarded registrant.
- + Not eligible with other offers or promotions such as special-pricing, demo units, other discount programs, etc.
- + Select ClearOne-authorized Canadian Distributors may extend this program to their Value-Added Resellers who are buying from them. In doing so, Distributors must place eligible orders separately for this program. These orders will be drop-shipped to resellers by ClearOne at Distributor's expense. Distributors will pass on the extra discount offered by ClearOne to their resellers.
- + When placing Purchase Order, resellers who are awarded discounts must make reference to this program for 5% discount processing.
